**VARIOUS STREETS, BELHAVEN, DUNBAR & WEST BARNs, TRAFFIC MANAGEMENT ORDER 2014**

NOTICE IS HEREBY GIVEN THAT EAST LoTHIAN COUNCIL PROPOSE TO MAKE AN ORDER IN TERMS OF SECTIONS 1(1) , 2(1) , 32, 35 AND 101 PART IV OF SCHEDULE 9 OF THE ROAD TRAFFIC REGULATIONS ACT 1984, AS AMENDED BY THE ROADS (SCOTLAND) ACT 1984.

THE EFFECT OF THIS ORDER WILL BE TO INTRODUCE TIME BASED WAITING RESTRICTIONS ON VARIOUS LENGTHS OF ROADS; TO RESTRICT VEHICULAR ENTRY, TO INTRODUCE WAITING AND LOADING RESTRICTIONS ON VARIOUS LENGTHS OF ROADS AND DIRECT TRAFFIC IN ONE DIRECTION ON VARIOUS ROADS IN BELHAVEN, DUNBAR AND WEST BARNs, EAST LoTHIAN. THE ORDER WILL AFFECT THE ROADS IN BELHAVEN, DUNBAR AND WEST BARNs, EAST LoTHIAN LISTED IN THE SCHEDULE HERETO.

A COPY OF THE ORDER AS PROPOSED TOGETHER WITH A MAP SHOWING THE ROADS AFFECTED, A STATEMENT OF THE COUNCIL'S REASONS FOR MAKING THE ORDER AND COPIES OF ALL RELEVANT DOCUMENTS ARE AVAILABLE FOR INSPECTION DURING NORMAL OFFICE HOURS AT RECEPTION DESK, JOHN MUIR HOUSE, HADDINGTON FROM MONDAY 2<sup>ND</sup> JUNE 2014 UNTIL FRIDAY 20<sup>TH</sup> JUNE 2014.
