Directors' report
for the year ended 30 November 2014

The members of the Board of Directors (“the Trustees”) are pleased to present their annual report and the financial statements for the year ended 30 November 2014..

Structure, Governance and Management

Sustaining Dunbar (“the Trust”) is a company limited by guarantee, with the liability of members limited to £1 each. The company is governed by the terms of its Memorandum and Articles of Association and is a registered Scottish Charity.

Members of the Board of Directors (“The trustees”) are elected from the membership at the AGM. At each AGM one third of the trustees reassign and are eligible for re-election. The council may at any time decide to appoint a member of the company as a trustee to fill a casual vacancy and also appoint a chairman and Vice-chairman from along their number. The maximum number of directors shall be 10; out of that number, no more than 7 shall be Member Directors and no more than 3 shall be Co-opted Directors. The minimum number of Directors shall be no less than three, of whom a majority must be Member Directors.

The names of those who were trustees during the year are shown on the information page together with other reference and administrative information.

Objectives, Renew of Activities and Achievements

Objectives and Aims

The principal objects of the Trust, as stated in the memorandum of Association are:

- (1) To advance education and, in particular, to promote opportunities for learning for the benefit of the general public
- (2) To advance environmental protection and improvement in the Community through the provision, maintenance and/or improvement of public open space and other public amenities and other environmental and regeneration projects (but subject to appropriate safeguards to ensure that the public benefits so arising clearly outweigh any private thereby conferred on private landowners)
- (3) To relieve those in need by the promotion of trade and industry within the Community for the benefit of the general public
- (4) To encourage, stimulate and support volunteering, principally in the Community
- (5) To advance citizenship and/or community development (including the provision of civic responsibility and the promotion of the voluntary sector)

But such that the company shall do so following principles of sustainable development.

Sustaining Dunbar is a Community Development Trust and a member of the Transition Network. Its aim is to bring people together to plan and start creating a positive and locally resilient future for the Dunbar and East Linton locality as we move away from reliance on fossil fuels and reduce our carbon and ecological footprints.

Objectives, Review of Activities and Achievements (continued)

Review of Activities and Achievements

Our fifteen year 'Local Resilience Action Plan' (2010-2025) continues to provide a guiding framework for Sustaining Dunbar's activities and priorities. A revised and updated version has recently been issued.

As last year, much of our work has continued to be funded by our three year grant from the Scottish Government's Climate Challenge Fund, which runs until March 2015. This has enabled us to continue running our Household Canny Challenge project which assists households to reduce their carbon emissions. As part of this, we have worked with local schools (Dunbar Primary, Innerwick, East Linton and Dunbar Grammar) and their pupil led 'Junior Climate Challenge Fund Steering Groups' to support their Eco-Schools (Green Flag) work, to deliver aspects of the Curriculum for Excellence and to encourage households to participate.

Assistance and support to households and community groups has included:

Transport: making it easier to walk, cycle and use public transport rather than private cars through basic bike maintenance classes, Dr Bike safety checks, cycle training for adults, a bike buddy scheme and work with East Lothian Council, Rural East Lothian Bus Users Forum, East Lothian Community Rail Partnership and others to improve public transport and plan improved cycling infrastructure.

Energy advice: our home energy audit service provides expert, impartial and personalised advice and support and works closely with the 'BeGreen' drop-in energy advice shop

Local food: assistance to households to reduce food waste and install worm composting boxes and support for household, school and neighbourhood food growing projects –notably Belhaven Community Garden, the vennel garden off Dunbar High Street, fruit tree planting at Wingate and the Dunbar Grammar School Chicken Coop.

We have continued to work with East Lothian Council and East Lothian Partnership to ensure that East Lothian becomes as resilient as possible to cope with future challenges. This included supporting community councils and neighbourhood groups to prepare their own resilience action plans.

Richard Lochhead MSP (Cabinet Secretary for Rural Affairs) launched Dunbar as Scotland's first official 'Zero Waste Town' pilot project in August. A project manager has been recruited and is now taking this project forward.

We have organized various awareness raising events, including film shows and discussion evenings, local food meals, a 'Bikefest' cycling festival and a 'Gathering-In' community event to raise awareness and stimulate discussion about the challenges and opportunities that will arise as we move to a low-carbon future. We have continued to support the use of our 'Our Locality' web platform providing over one hundred

Websites for local organizations and projects, strengthening local links and networks and contributing to our goal of building local resilience. We have also supported events organised by others, including Dunbar Community Woodland Group and North Light Arts and actively supported other community organisations across Scotland through the Scottish Communities Climate Action Network and by contributing to events organised by Community Woodlands Association, Transition Network and others.

Our main volunteer run project has continued to be Belhaven Community Garden and orchard in the grounds of NHS Belhaven Hospital. This year we have been able to extend the orchard and growing area and install wheelchair accessible paths. An active beekeeping support group and learning circle has been established and now has several active hives around Dunbar and East Linton.

We have supported a local stakeholder group in East Linton who are investigating the potential for purchasing the former East Linton Saleground for use as a community hub and centre for community enterprise.

We continue to investigate options for community energy projects and are researching the potential for community owned solar photovoltaics at different scales. We are also working in partnership with Community Energy Scotland to explore the future role that hydrogen may play in providing energy storage in the future local energy economy.

Financial Review

The results for the year are summarised in the Statement of Financial Activities (SOFA) on page 5. Net incoming resources for the year amounted to £12,400 (2013 (£15,186)).

Total incoming resources amounted to £215,693, and included £213,233 from project grants and £2426 from consultancy and events.

The movement in funds over the year is summarised in the notes to the accounts. There are total funds of £41,564 carried forward of which £1948 represents the value of tangible fixed assets.

Assets and Liabilities

No costs were added to tangible fixed assets during the year.

Reserves Policy

The directors aim to maintain free reserves of the charity at a reasonable level to provide working capital for salary and overhead costs.
