1 To what extent do you agree with the framework proposals for Ministers and public authorities to prepare statements of policy, have regard to them in the exercise of relevant functions, and report on implementation, with regard to international obligations and guidance?

Please explain your answer. :

This response comes from Sustaining Dunbar, a locality based Community Development Trust. We strongly identify with the aims of the GFN initiative and wanted to engage with a range of people in our community on these issues. However the format of the consultation was not accessible to many of them. Therefore we developed a survey that would include all the relevant issues in a more accessible format. The survey was advertised through local social media, networks and community groups.

We received 81 completed responses indicating that policies should address all aspects of the food system. Respondents were clear that principles of fairness, equality and environmental sustainability should be embedded in policies that are supported in law. With regard to placing requirements on food related businesses we understand the concerns expressed by SG however we feel that the essential aims would be undermined if no requirements were in place.

This is a fundamental element of broadening awareness of what the GFN initiative means and in its realisation. Standards should be regarded by food businesses as a positive way of promoting their products and a GFN standard mark could be introduced (like the kite mark standard) as a marketing tool.

3 To what extent do you agree with the proposed approach to accountability of Scottish Ministers and specified public authorities?

Strongly disagree

Please explain your answer.:

90% of our respondents agreed that the Scottish Government and other public authorities should have policies for Good Food and that they should take action to improve our food system.

80% agreed that the benefits of good food for people and nature are too important to leave to Parliament alone.

An independent statutory body should be set up to protect everyone's right to food and to make sure that the Government keeps its promises. It is the view of Sustaining Dunbar that an external body would be better able to monitor activities and highlight discrepancies. We are aware that the Government needs to balance a range of interests but may be verly pragmatic in the face of pressure from industries.

Independent bodies have been set up to review land reform and inequalities and their role is significant in keeping these issues in the forefront when driving the process of cultural change. Scottish Government suggests that establishing an independent body would result in burdensome costs and administration and should only be considered in exceptional cases. We think that given the growing problems of food poverty, diet related health issues and the environmental crisis we are facing, then this is an exceptional case and should be considered as such. While there are bodies that deal with the aspects identified we would suggest that a thematic approach would encourage joined up thinking and help to deliver these goals effectively.

Our survey did not specifically ask questions about framework legislation as it was thought that this was an area with which many of our respondents would not be familiar. However the strength of their responses suggests that there is a need for firm commitment to addressing the problems inherent in our current system and that responses should be guided by the principles and ethos to which we are committed. We believe that opportunities to grow food promote wellbeing, eating together, having the skills and confidence to cook and an acknowledgement of the cultural significance of what we eat are all important in changing the dysfunctional systems that we currently promote.

The framework needs to be strong and the targeted legislation should be responsive the the issues identified.
