Dunbar Shore and Harbour Neighbourhood Group (DSHNG) remains a fully constituted Tenant's and Resident's Association and has representation on the East Lothian Tenants' and Residents' Panel (ELTRP).

Membership for 2016/17 stands at 65 and has remained constant with some leavers and some joiners.

Meetings started with the AGM in February and we met every month until June. After a summer break, meetings were held from September to November. All were open meetings and all were generally attended by no fewer than 8 people and generally no more than 15. We remain grateful to Dunbar Methodist Church for continuing to allow us to use their hall.

Open meetings were almost exclusively updates on current projects. Minutes are emailed to all members, local councilors, Community Councillors and Dunbar Trades Association and are posted on DSHNG website. Members without email may get paper copies but this does not always happen

Live projects are managed outwith meetings and for 2016, these projects have included:

CREEL LOADERS – Statue, garden, paving and interpretation panel

Project value: £40k

Team: Kevin Heffernan, Ian Dane, Brian Cox.

Project: The team successfully delivered The Creel Loaders statue in September

and are now working on the delivery of an interpretation panel for which funding has been granted by ELC. The panel is expected to be in place

by Easter 2017.

VICTORIA STREET HISTORY HUB – Interpretation panels, paving and seats

Project value: £15k

Team: Kenny Maule

Project: Kenny has led this project from the outset. 11 panels telling the story of

Victoria St will be installed in February. It is hoped that paving works,

incorporating Rita Bradd's Herrin' Road poem, will be complete by the

summer.

EAST BEACH REGENERATION – Coastal defences and beach improvements

Project value: £1.5m +

Team: Pippa Swan supported by full East Beach Regeneration Team (DSHNG,

ELC, Scottish Water) + Consultants (RHDHV, OOBE Design)

Project: The team has determined a trial in an attempt to encourage self

regeneration of the East Beach. Infrastructure to be constructed before 2018 will include a new 'bio' groyne and defence mattressing to the

sewage interceptor pipe. (c£300k)

A design for an upgrade to Lamer Street has also been identified and this

will inform ongoing sea defence work. (Guesstimate - £1m +)

The project has attracted wide interest and Kenny Maule has

presented/will present to Forth Estuary Forum and SNH.

EAST BEACH KELP MANAGEMENT – Contractor management for kelp removal

Project value: £20k plus

Team: Pippa Swan with Mike Shaw

Project: Analysing issues after large kelp dumps, liaising with ELC, organising

contractor, managing publicity. This year we had several one/two day clearance projects and one seven day project which cost ELC something

in the region of £15k. Thanks go to AG Thomson for being endlessly

inventive and helpful.

EAST BEACH CLEANS - Monthly beach cleans in summer
