Friends Of Winterfield – Treasurers Report 2012 – 2013

After the Friends of Winterfield (FoW) group was set up in 2011 advice was provided by the local councillors and East Lothian council staff regarding monies which might be available for improving the environment in Winterfield Park. The committee is grateful to Esther Hughes, Secretary, for pursuing these leads which has resulted so far in a very worthwhile sum of money being donated.

East Lothian Council Environmental Community Fund - £2996.00 to be used for improvements to the park including a Picnic area, park benches and waste bins some of which are already in place.

Dunbar Community Council – £500.00 for set up and stationary cost; Stamps, printing, paper etc.

Civic Pride Fund - £5000.00; this is to be used for further upgrades to the park, including improvements to the East entrance gate (Public Park entrance), planting of shrubs near this area, a vehicle barrier and more benching.

Committee Member Sue Anderson arranged a Fun Dog Show on 18th June 2012 which, although it incurred some costs, was a success as it encouraged people to visit the park and raised awareness of FoW. Another such show will be held on 22nd June 2013 which we hope will be a financial success as well as a social one. We have already reduced the organisation costs and made other changes which we hope will result in a profit.

Looking at the balance sheet FoW seems to be cash rich at present. Much of the work listed above has been carried out by the ELC and we very much appreciate their help and efforts. Unfortunately however, despite several requests from Esther and myself, we have yet to receive any Invoices for the above projects from the council, mainly due to some of those projects requiring some further work to be carried out to finish them.

Those who visit the park will have noticed and perhaps made use of the picnic benches and other benches in the area around the entrance and Tennis Club, as well as the new flower / shrub beds and planting in progress. Hopefully visitors and especially dog walkers are making good use of the new waste bins in the park!

We are grateful to Dunbar Community Council who kindly donated us a very nice bench which has been used appreciated by visitors.

There are many other projects in planning by the FoW group including a Trim Trail and upgrading of the entrance and wall in front of the park.

I would like once more to mention Esther Hughes our Secretary works very hard completing applications for funding and her work has been most successful in raising monies for all the above projects. Many thanks to Esther without whom we would not have been able to make the progress we have done. We are already in receipt of £4400.00 from the Civic Pride Fund for further work to be carried out in 2013 -2014.
